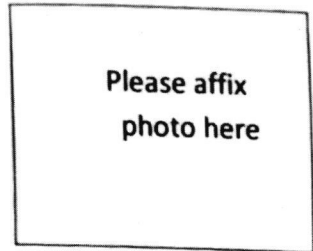

**Norms for Selection of legal practitioners as panel lawyers**

1. The advocate not less than 5 years standing and not more than 20 years standing, as on 01.01.2024, may apply for being empaneled.
2. The advocate must be enrolled in Rolls of High Court, Allahabad.
3. The advocate must be enrolled in the Bar Council of Uttar Pradesh.
4. The advocate must be a member of High Court Bar Association or Advocates' Association High Court Allahabad.
5. The Advocate should provide a list of cases conducted by him which has been published in a journal annexing some judgment.
6. The Advocate who has been convicted of any offence or against whom any proceeding initiated for professional misconduct or contempt will not be considered.
7. Furnishing of PAN number should be made compulsory.
8. Income Tax Return of 3 year should be furnished.
9. For Ex-panel lawyers, judgment of five cases conducted as a Panel Lawyer
10. The advocate will be empaneled through interview.
