With reference to his/her application in response to **Advertisement No. 01/Law Clerk (Trainee)/17** for being considered for the post of Law Clerk (Trainee) in the High Court of Judicature at Allahabad, he/she is hereby informed that he/she has been selected as a Law Clerk (Trainee) to be attached with an Hon'ble Judge for a period of one year on a fixed honorarium of Rs. 12,500/- with no other allowances and without any other perquisite such as residential accommodation etc. The engagement shall be purely contractual for a fixed term of one year, which may be terminated at any time if the incumbent is found lacking.
